## Meeting called to order at 5:02pm

#### Public Comment: none

**Minutes:** John Y moved to approve July minutes, Marcy seconded, approval was unanimous (10-0-0)

#### Finance Committee report: attached

Fred noted expenses are down by over \$15K from 2016, asked if there was any big contributor to that decrease (Justine leaving, perhaps?). Rick: no one significant line item; some here, some there.

#### Executive Director's report: attached

**Executive Director Bonus:** Ira noted that John Braden had not taken a cost-of-living salary increase this past year, and since the Summer pledge drive had been an overwhelmig success, he suggested we consider a one-time bonus for John. John Yingling moved to give John Braden a one-time \$1500 bonus, Susan seconded, approval was unanimous (12-0-0)

**2018 Budget:** Finance Committee reported that they had reviewed the proposed 2018 budget and recommended approval. Fred moved to approve the budget, Sheila seconded, approval was unanimous (13-0-0)

**Broadcast Equipment Capital Campaign (BECC):** The BECC Committee has had their first meeting and discussed how to raise the necessary funds and a draft of the case for the BECC has been written. The committee is made up of Marcy, Rick, Susan, Dave, John Y, Ira, Bruce, and John B.

It turns out that the budget proposal from Chris Kelly (broadcast engineer) has increased, based on wishes discussed in conference call, and that the proposed Orleans studio is a significant portion of the funds. The current quote is for a setup essentially the same as that for Studio A, and there are ways to modify things in order to decrease the costs. The decision was that we need to make this decision before going public with the BECC, but that it requires a meeting devoted primarily to this topic. The BoD will discuss the plan for an Orleans Studio at the October meeting.

**Presentation of BECC:** Tony presented four slides outlining initial plans for the BECC (attached). BoD members should expect calls from BECC members to get pledges for the campaign. BECC expect 100% support from BoD to raise at least 25% of capital to come from BoD members. This will show committment to potential contributors. Contributions may be distributed over 2017 & 2018. The campaign has begun with this BoD presentation, even though we are not promoting it publicly yet.

## Minutes: WOMR Board of Directors Meeting – Septmeber 12, 2017

**Old Business: Nominating Committee and Bylaws:** In the past there had been some discussion of making the Nominating Committee a standing committee, and that if we wanted to make that change this year, it may require amending the bylaws, which must be proposed well before the annual meeting. Bob reported that he had reviewed the bylaws and there is no mention of the NomComm other than a vote on its slate of members at the annual meeting. Any change to the makeup or term length of the NomComm is part of the policy and can be handled by the Policy Committee and BoD.

While we were discussing bylaws, it was mentioned that the current bylaws require that the annual meeting be held in Provincetown. This will be revisited/discussed by the BoD in Summer 2018.
